



Checklist: Are You on the Path to Financial Freedom as an Entrepreneur?

1. Redefine Money's Role

- Do you view money as a tool to create freedom, rather than an end in itself?
- Are your financial goals centered around gaining more control over your time and choices?

2. Prioritise Long-Term Planning

- Have you created a clear, long-term business plan (even if it's not a formal, extensive document)?
- Are you building your business as an asset that could eventually be sold, not just as an income source?

3. Diversify Your Income Streams

- Do you have multiple sources of income, or are you working towards creating them?
- Have you invested in areas outside of your core business (e.g., stocks, real estate, other businesses)?

4. Invest for Growth

- Are you continuously learning and improving your skills, but with a clear purpose that directly benefits your business?
- Are you investing in business strategies, technologies, and marketing that promote long-term growth?

5. Manage Debt Prudently

- Do you have access to credit or debt that can help seize opportunities without harming your cash flow?
- Have you ensured that your debt is manageable and well-structured, with favourable terms?

6. Seek Professional Guidance

- Do you have a qualified financial adviser or mentor who helps guide your financial decisions?
- Have you built a "support team" of professionals to handle areas outside your expertise (e.g., legal, accounting, insurance)?

7. Embrace Change and Stay Open to New Ideas
